Thank you for making 2021-2022 another remarkable year for the New Canaan Society for the Arts. This year marks 45 years of service for the organization, promoting the visual and performing arts; enriching the community through exhibitions, education, and cultural experiences; and operating the Carriage Barn Arts Center.

When the organization was founded in 1977, a passionate group of local artists and arts patrons envisioned a place where ALL would be welcome to learn, share and find inspiration from the arts. The continued support of members and donors have made this possible, and we're confident that the founding members would be proud of how the Carriage Barn has evolved and grown.

In addition to presenting twelve diverse and well received art exhibits, the past year included many other highlights. We worked with the Town of New Canaan to complete a renovation to the facility that includes the addition of air conditioning, ADA compliant restrooms, a dedicated space for education programs and meetings, and an enlarged reception and office space. These improvements have already resulted in increased use of the Carriage Barn through year-round programs, additional classes and workshops, and rental events.

The Carriage Barn Arts Center continues to attract new audiences and engage with the community through partnerships, innovative programs and new marketing efforts. With the recent addition of two new staff members focused on programming and outreach, we are confident activities and engagement will continue to increase.

We are looking forward to an exciting year ahead filled with new exhibitions, new programs and workshops and many new initiatives to continue the promotion and support of the arts in our community. We thank you for your support, and hope that you will join us again this year for all of the great happenings planned at the Carriage Barn Arts Center.

OUR MISSION

The mission of the New Canaan Society for the Arts, Inc. is to promote the visual and performing arts, enrich the community through exhibitions, education, and cultural experiences, and to operate the Carriage Barn Arts Center. The Carriage Barn Arts Center offers artists opportunities to exhibit their work in an exceptional gallery space in a unique nineteenth-century stone barn. Exhibits, lectures and educational workshops, concerts and other events are held in this adaptively reused historical building on the grounds of a former estate, now Waveny Park.

Our History

The New Canaan Society for the Arts, a member-supported, nonprofit cultural organization, was founded by a group of artists and art lovers in 1895. Much as it is today, the organization's goal was to encourage creative expression, celebrate artistic achievement, and enrich the community as a whole. Little is known of the Society's early years and how long it remained active. It was not until 1977, when a plaque was discovered, that a group of New Canaan residents banded together to reestablish the New Canaan Society for the Arts, Inc. This group of artists and art lovers petitioned the Town for the use of the Carriage Barn in Waveny Park, which had remained empty since the purchase of the estate in 1967. Dedicated volunteers restored the charming 100-year-old Carriage Barn and within the year opened the doors to offer unique cultural experiences in an exceptional gallery space to the New Canaan community and beyond.

Today the Carriage Barn Arts Center is home to premier art exhibitions, including juried events, as well as curated exhibitions featuring both members and invited artists. In 2011, the Carriage Barn launched an initiative designed to showcase the work of talented high school students — and every spring, the Carriage Barn presents Art in the Windows, which places art in retail shops in New Canaan for the enjoyment of pedestrians and shoppers.

The Carriage Barn Arts Center is open five days per week from September through June (closed Mondays and Tuesdays). Entrance to the Gallery is free and all exhibitions are open to the public.


